Do Not Diagnose Biliary Colic if Pain is More Than 6 Hours' Duration

ost of the times, gall stones are silent but if they do cause an attack of biliary colic similar to renal colic, there is very severe pain felt in the epigastrium and right hypochondrium and at the back associated with severe vomiting and

sweating.

However, it is very important to remember that if this pain lasts for more than 6 hours, the patient has either developed cholecystitis or acute pancreatitis. Repeat sonography and blood tests like CBC to see leucocyte count, Serum Bilirubin and Serum Amylase. They will help in the diagnosis.

Prognosis in a Liver Patient

When the liver patient becomes serious, do not judge the prognosis

from SGPT. Prothombin time is the best indicator for poor prognosis. Also platelet count and Creatinine levels will help.

Endogenous Depression

Endogenous depression is extremely common in private practice. The diagnosis is missed because there is no blood test or imaging showing this illness.

Any patient who complains of feeling low, insomnia, weakness specially early morning when he has no desire to go to work, with spells of crying, has got endogenous depression.

Do not send these patients to a psychiatrist. Moment the treatment is started by any anti-depression tablets like Amitriptyllin, the patient shows improvement within few days. By the end of 3 weeks he becomes normal but the medicine should be continued for 6 months. However, if the patient does not improve by 3 weeks, never treat the patient further and then he should be referred to a psychiatrist.

Blood Tests of CPK and LDH

Most of the times in health check up, the most useless tests (which are often abnormal) are CPK and LDH. However, in a fever patient, this test can become useful in giving the diagnosis like a

very high CPK is suggestive of Leptospirosis and a very high LDH is suggestive of malaria specially falciparum malaria. At other times, an occasional patient consuming statins might show high CPK. Similarly, LDH is raised in macrocytic anaemia.

Podagra and Uric Acid

Podagra is an attack of Inflammatory Arthritis (pain, redness, feverish, leucocytosis) usually affecting the big toe or any other area of the foot. If an aspiration of the joint is carried out, there is no pus but yellow pus like liquid which an examination will show uric acid crystals. Blood uric acid levels are normal. Treatment is strong pain killers like Indomethacin in very large doses like 2 hourly or 1 hourly. Steroids can be used.

No Anti uric acid drugs at all. Such patients can develop gout after few years.

Hyperuriceamia is very common in our population-specially in people having high cholesterol or lipids and does not call for treatment and is usually less than 10mg. Very high levels are seen after using drugs like PZA or Haematological drugs when Uric acid lowering drugs have to be used.

Finally it is worth remembering that if an elderly person is having Rheumatoid Arthritis picture, but Anti CCP test is normal, high uric acid levels will favour the diagnosis of "Chronic Gout"

Cost Effectiveness / Yield / Medical Economics 2 D Echo Against E.C.G. in Myocardial Infarction

Por so many years, E.C.G. was used as one of the best investigations to confirm myocardial infarction. The time

has come when in addition to Troponin levels in the blood, 2-D Echo is required to confirm the diagnosis of myocardial infarction. In future, all Cardiologists will have to keep 2D Echo machine, preferably the latest portable one equivalent to stethoscope.

Antiplatelet Therapy after Ischemic Stroke or TIA

The combination of aspirin plus clopidogrel reduces the chance of recurrent ischemic stroke during the high-risk period in the first few weeks after a TIA or noncardioembolic ischemic stroke. However, to confirm the results of the POINT trial, if dual therapy is used, it should be confined to the first 3 weeks after a TIA or minor stroke and then transitioned to monotherapy. If patient follow-up and adherence to therapy are not reliable, then dual therapy perhaps should not be considered. Dual therapy may also not be advisable in patients with an uncertain diagnosis of TIA, who either would have been excluded from the trial or did not benefit. Finally, patients who are at increased risk for bleeding, such as those with cerebral microbleeding or a history of brain or systemic bleeding, were excluded from this trial and may not be appropriate candidates for such dual therapy.

New Biologics for Asthma

Dupilumab, a monoclonal antibody directed against the alpha subunit of the interleukin-4 receptor that inhibits interleukin-4 and interleukin-13 signaling, has a salutary treatment effect in severe asthma.

It is likely that these data will lead to approval of dupilumab for the indication of severe asthma. If so, in the past few years four new biologics - namely, mepolizumab, reslizumab, benralizumab, and dupilumab - that are directed largely against type 2 inflammation, broadly writ, will have been introduced for the treatment of asthma.

Although we are doing the research to find these markers, how will we decide which of these treatments should be used now?

We envision a trial in which patients meetings specific asthma and biomarkers criteria would be enrolled and assigned randomly to one of the four active treatments.

Motility disorder of the oesophagus is quite a common cause of dysphagia.

This illness is always missed on endoscopy. Always send such patients for Barium bolus examination of the oesophagus under video fluoroscopy.

Why Are Small Ill Equipped ICCU Units in the Suburbs Surviving?

Even then many patients survive, Why? Because these patients are survivors of the storm. Most of the patients who are going to die, do so within 2 hours of the attack. Thus, if the patient reaches the hospital after two hours, his chances of survival are good.

Disease Pattern In India High Normal BP and Not Hypertension

The diagnosis of "hypertension" carries sentence of life time medication and therefore disliked by the patients. Therefore, whenever you have a patient less than 50 years old and if the BP is not

more than 150/90 constantly, it is better to tell the patient that he has high normal BP and advise him to lose weight, start low salt diet and start regular exercises. There is nothing wrong in waiting for few months. Also see that the patient becomes conscious of his BP for which he will not mind starting medicines later on whenever required.

Four Months of Rifampin or Nine Months of Isoniazid for Latent Tuberculosis in Adults

A 9-month regimen of isoniazid can prevent active tuberculosis in persons with latent tuberculosis infection. However, the regimen has been associated with poor adherence rates and with toxic effects. The 4-month regimen of rifampin was not inferior to the 9-month regimen of isoniazid for the prevention of active tuberculosis and was associated with a higher rate of treatment completion and better safety.
